The work "C/o 40 Nos. SPS (D/S), 5 Nos. staircase, 7 Nos. toilet blocks at Govt. S.K.V. Old Seemapuri, Delhi" was inspected. The progress of the work is about 93%. The following directions were given.

- The flushing valve should be provided instead of flushing cistern. (a)
- Instead of normal urinal system, the granite in the wall and partition (as per S.S.A. norms) should be (b) provided. (The same provisions have been provided in the existing boys toilet of GGSSS East Gokalpur).
- Only 1% progress is achieved in last one month, E.E. was asked to take action for delay in the work as (c) per provisions in the agreement and ensure that work should be completed by 30/10/2014.

The Govt. S.K.V. Old Seemapuri building was also inspected and following directions were also given.

- The construction site of 40 Nos. SPS has been cleared to some extent. The debris/malba stacked is to be (a) removed. The before and after photographs should be taken for Swachta Abhiyan.
- The construction site of 2 Nos. girls toilets under Sarv Shiksha Abhiyan is yet to be cleared. A.E., M-2221 was asked to coordinate with A.E., M-2211 for getting the site cleared within three days. The before and after photographs should be taken for Swachta Abhiyan.
- In the renovation work of toilets at G.F. in the existing building the wall tiles have been fixed in a very (c) shabby manner. The toilets at G.F. were not non-made functional & the work at F.F. toilets were started. The directions were given to make the G.F. toilets functional within a week's time.
- It was also directed to make available the 6 Nos. new toilets being constructed within 15 days and the same should be handed over to school authorities.
