Inspection Note

The Chief Engineer, PWD, Maintenance Zone M-4 has inspected roads under Division M-441 along with Shri M.K. Mallick, Superintending Engineer, M-44 & AE/M-4412 on 16/10/2014.

Following observations have been made:-

1. Hans Raj Gupta Marg:-

(A) Drain Work:- Drain work was in progress, following observations were made:-

(i) One stack of bricks was found to be not satisfactory. This is to be immediately removed from site and only quality bricks are to be allowed to be used in work.

(ii) At places, brick joints were not filled up properly. It was directed to dismantle such portions of brick work & to redo the same.

(iii) Paver Blocks & Kerb stones brought to site do not have any marking of the company & are to be rejected. Only good quality paver blocks/kerb stones of approved make are to be used.

(iv) The excavated materials and malba needs to be removed immediately to avoid any inconvenience to public.

(B) Patch repair work:

- Road opposite M block market has potholes. It was directed that proper demarcation /identification of patch area is to be made before doing patch repair works.
- (ii) Patch work needs to be expedited and completed on priority.
- (iii) Malba lying along the road should be removed on regular basis.

2. Drain work of Durbal Nath Marg:-

- (i) One stack of bricks at site was not found to be of proper quality & is to be rejected & removed from the site.
- (ii) Proper joint fillings in the brick work is to be ensured.
- (iii) Excavated materials after refilling needs to be removed as early as possible.

3. Dakshinpuri Marg:-

 RMC work on the berm portion at many places is not up to mark. It needs to be immediately rejected and is to be redone by the agency.

4. Maharishi Balmiki Marg:-

- (i) Works of footpath and central verge are yet to be finished.
- (ii) At few places, road work is yet to be finished.
- (iii) Malba was found lying along the road & should be removed early.
- (iv) Posters/banners have not been removed properly on this road & should be removed on priority.
