Sub: Inspection diary of Shri Dinesh Kumar, Engineer-in-Chief, PWD for the week from 1st to 5th of September 2014.

1/9/2014 : Inspection of Ashram Flyover.

Ashram flyover was inspected where Project Manager, F-12, E.E, F-122 along with representative of the contractor were present. The work for replacement of expansion joints was inspected in detail and it was directed to increase the number of traffic marshals for smooth flow of traffic. Instructions were issued to expedite the work and restrict no traffic area to the minimum. Revised schedule was directed to be reduced for 45 days for completion of entire bridge instead of 60 days. Detailed inspection note is to be issued by Project Manager, F-12.

2/9/2014 : Joint inspection with Shri Ramesh Bidhuri, Hon'ble M.P.

Joint inspection-cum-meeting was held with Shri Ramesh Bidhuri, Hon'ble M.P of South Delhi Constituency where C.E, M-4, S.E, M-41, M-44, M-45 were present along with other staff. The Hon'ble M.P was briefed about the project of corridor improvement plan of M.B Road from Lado Sarai to Badarpur Border and corridor improvement plan for Andheria Mor to NH-8. For giving details of the project, a separate meeting was proposed with Hon'ble M.P by S.E, M-11, Project Manager, F-11 and S.E, M-44.

Suraj Kund Road as well as M.B Road was also inspected. Suitable directions were issued to C.E, M-4 and S.E, M-44 for improvement work as short term as well as long term basis. Detailed inspection note is to be issued by C.E, M-4.

3/9/2014 : Meeting with Hon'ble, L.G.

There was a meeting with Hon'ble L.G at 10.30 a.m regarding SRDC work; hence no inspection could be done.

4/9/2014 : Inspection of Mehrauli – Mahipalpur Road.

Mehrauli – Mahipalpur Road from Andheria Mor to Nelson Mandela Road was inspected along with Pr. C.E, M-1, S.E, M-11 and their staff. It was directed to expedite the work of widening of Mehrauli – Mahipalpur Road from Andheria Mor to Aruna Asaf Ali Marg where stay of NGT has already been vacated. It was directed to start the work within a week and details may be worked out.

The work of RTR Marg near RR Hospital was also inspected and suitable instructions were issued to expedite the work. Detailed inspection note is to be issued by Pr. C.E, M-1.

5/9/2014 : Meeting with Chief Secretary.

There was a review meeting with Chief Secretary reg. Swachhh Bharat Campaign Delhi at 9.30 a.m; hence no inspection could be done.
