Sub: Inspection diary of Shri Dinesh Kumar, Engineer-in-Chief, PWD for the week from 04th to 08th of August 2014.

04/8/2014 : Inspection of Bhairon Road and Ring Road from Rajghat to Ashram.

Inspection of Bhairon Road & Ring Road from Rajghat to Ashram was conducted where E.E, M-413, Director (Hort), M-414 and E.E (P), M-41 were present. There is drain work going on near Gate No.2 of Pragati Maidan. E.E, M-413 was asked to take full alignment of the drain and ensure that the subway on Bhairon Road is not damaged due to MCD work. Minor potholes and repair work on Bhairon Road was directed to be attended immediately. The damaged horticulture work by road cutting permission of various agencies, required to be re-done immediately. On Ring Road near Millennium Park; the entire green belt has been damaged by DJB for laying water supply line. D.D (H) was directed to take up the work on war footing basis so that the horticulture and removal of malba are completed within a month so that greenery is fully developed after rainy season.

05/8/2014 : Inspection of Janakpuri Hospital.

Inspection of Janakpuri Hospital was conducted where Pr. C.E, M-1, S.E, M-13, S.E (E), M-15, S.E, B-23 and Architect were present along with their staff. Detailed inspection was conducted for which inspection note is to be issued separately by S.E, M-13. For developing new residential and medical block, Shri Satish Sabbarwal, Architect was directed to finalize the drawings within a week and send to Director of the hospital so that the work can be taken up at the earliest. S.E, B-23 was directed to follow the same.

06/8/2014 : Meeting with Hon'ble L.G.

There was a meeting with Hon'ble L.G regarding Delhi budget and road map at 10.30 a.m; hence no inspection could be done.

07/8/2014 : Meeting at E-in-C office.

A meeting was conducted in E-in-C's office to review the works of Social Welfare/Women & Child Department and Education department; hence no inspection could be done.

08/08/2014 ; Meeting with Hon'ble L.G

There was a meeting with Hon'ble L.G at 10.30 a.m but the same was changed to 2.45 p.m; hence no inspection could be done.
