Sub: Inspection diary of Shri Dinesh Kumar, Engineer-in-Chief, PWD for the week from 9<sup>th</sup> to 13<sup>th</sup> of June 2014.

**9/6/2014** : Presentation before Hon'ble L.G.

There was a presentation by Social Welfare Department before Hon'ble L.G which was cancelled before start of the meeting; hence no inspection could be done.

**10/6/2014** : Meeting with Hon'ble L.G.

There was a meeting of Apex Committee on Flood Control Measures at Raj Niwas; hence no inspection could be done.

**11/6/2014** : Visit of Chief Secretary.

Chief Secretary visited Super Specialty Hospital at Janakpuri where Secretary (Health), Secretary (PWD), E-in-C, PWD, S.E, M-13, S.E, M-15, S.E, B-23 were also present. Chief Secretary visited the entire campus and issued instructions for further development as per the requirement of Health Department for which S.E, M-31 was directed to co-ordinate a meeting with Medical Superintendent/Director of the Hospital where S.E, M-15, B-23 and Architect may also be called for discussing the requirement of hospital so that further development programme/scheme can be developed. This may be done within a week by S.E, M-13.

**12/6/2014** : Joint inspection of Gautam Nagar nallah.


A joint inspection was done for Gautam Nagar nallah with South Delhi Municipal Corporation (SDMC) where E-in-C, PWD, Pr. C.E, M-1, S.E, M-11 and S.E, SDMC were present along with their staff. It was noticed that lot of desilting of Gautam Nagar

nallah is to be done by SDMC from Gautam Nagar road to behind Indian Oil Building. Though desilting work was in progress, but the same needs expediting. Therefore SDMC was requested to increase the progress of work so that desilting is completed before 30/6/2014.

PWD work for desilting of drain from behind Indian Oil Building up to Green Park was also inspected. E.E, M-113 intimated that desilting will be completed within next 3-4 days which may be strictly adhered to.

The work of construction of culvert on Aurbindo Marg was in progress which needs to be expedited on war footing. Pr. C.E, M-1/S.E, M-11/E.E, M-113 was directed to ensure that the culvert work is completed by 30/6/2014 so that there is no drainage problem on Aurbindo Marg.
