The Chief Engineer, PWD, Maintenance Zone M-4 inspected the Ring Road from ITO Chowk to Timarpur Chowk, S. P. Mukerjee Marg, H. C. Sen Marg and Chandni Chowk Road under Circle M-41 along with Sh. G.P. Bansal, SE/M-41 on 23/02/2015. Following observations have been made:-

Inspection Note

Ring Road from ITO Chowk to Hanuman Setu: 1.

- > The Kerb Stones and carriageway was found settled near Rajghat left turn towards Jawahar Lal Nehru Marg and is to be attended on priority.
- > Thermoplastic paint has worn out at various places and is to be got redone by the Agency if it is under maintenance period.
- Toe wall and kerb channel are damaged near Ghata Masjid & should be repaired.
- Lot of grass has come up on the footpath which is to be removed.
- Malba was found along the wall of garden behind Lal Quila which is to be removed.
- Nosing and railing was found damaged at Mangi Bridge & should be repaired.
- The wall of the Mangi Bridge underpass is to be painted.
- On Ring Road Bypass, the carriageway found settled near Pili Kothi. It is to be attended on priority.
- Some small potholes were found on Ring Road Bypass.
- Restoration work near Hanuman Setu is pending for long time & needs to be completed expeditiously.

2. S. P. Mukerjee Marg :-

- The Kerb Stone were found dislocated / damaged at places.
- There were undulations on footpath at places which needs to be attended.
- Same potholes were also found which may be repaired immediately.
- The potholes at Lothian Chowk are numerous which may be repaired immediately.

3. H. C. Sen Marg :-

> The drain work is very slow. Suitable action as per agreement may be taken against the agency for delayed performance.

4. Chandni Chowk Road :-

> MTNL has not started the work. Sh. A. K. Pait, EE-SRD Project, PWD stated that MTNL has finally decided to fix the feeder pillars first and connect it with the old line. The cables will be drawn afterwards. MTNL may start the work by 25-02-15.

> The matter related to providing base plate below the feeder pillar was also discussed and it was decided that base plate may be provided in consultation with EE (Elect.) PWD.

> The drainage of ducts was also discussed and it was directed that final decision may be

taken in consultation with SE (Elect.), PWD.

The progress of work needs to be expedited.
