



Inspection Note

The Chief Engineer, PWD, Maintenance Zone M-4 inspected following roads under Circle M-44 along with Sh. M.K. Mallick, SE/M-44, Shri Pratap Singh, EE/M-441 & Shri R.S. Garg, EE/M-442 on 30/04/2015. Following observations have been made:-

(A) Press Enclave Road :-

1. At places, lot of road surface noticed cracked badly. The damaged surface is to be sealed immediately with rubberized bituminous work before monsoon.
2. Cracked mastic at junction may be replaced by SMA immediately.
3. Footpath and side lane damaged badly near Saket Court Mandir Marg T-junction should be repaired immediately.
4. At T- junction kerb stone etc. should be repaired immediately.
5. Photo of open dhalao opposite Saket Hospital may be sent to MCD for proper disposal of garbage etc.
6. At number of places central verge is full of rubbish etc. to be cleaned immediately.
7. The shrubs/plant may be cared properly by Horticulture DD M-414.
8. There is lot of encroachment near Max Hospital by Gadia Lohar on footpath. The unauthorized encroachment programme may be prepared immediately and action may be taken up accordingly.
9. Grill of central verge tilted/damaged at number of places to be checked thoroughly and repair immediately.
10. Pot hole in the main carriage way at T-junction of PVR road, undulation at T-junction of Basant Kaur Marg in main carriageway to be rectified immediately.

(B) Mandir Marg :-

1. Footpath is broken at places, it needs to be repaired.
2. Malba of drain may be removed immediately.

(C) M.B. Road:

Central Verge needs to be cleaned and to be made free of rubbish.

(D) Mandi Road :

1. Malba of drain may be removed immediately.
2. Gadaipur water logging : Site was inspected, needful action is to be taken on priority.
