Sub: Inspection of Superintending Engineer, M-41, PWD of Ring Road & NH-2 on 06-05-15.

The undersigned inspected the Ring Road & NH-2 along with Sh. C. S. Azad, Executive Engineer, M-412, PWD and concerned Assistant Engineer in charge on 06-05-15.

1. Ring Road :-

- (i) Sh. Chander Shekhar Azad, EE, M-412, PWD.
- (ii) Sh. G. A. Khan, AE, M-4123, PWD.
- The kerb channel needs cleaning regularly. It seems there is some laxity in cleaning of kerb channel and bell mouth. The bell mouths at various places are not maintained properly.
- The service road near Andrews Ganj upto August Kranti Marg point is not in good condition.
- During the inspection, it was found that alligator cracks are appearing on the road surface. The Executive Engineer intimated that necessary action for filling of the cracks is being taken.
- The maintenance van is required to be activated efficiently as at some places the repair of nosing / footpath to be handled by maintenance van is not being done.

- (ii) Sh. A. K. Dixit, AE, M-4122, PWD.
- The maintenance of this stretch (Ashram chowk to Mata Mandir Marg) of road is not satisfactory inspite of the directions given by the undersigned many times, though replacement of interlocking paver blocks was going on near Friends Colony.
- There are number of vulnerable points on NH-2 & at Ashram Chowk related to water logging, EE, AE & JE in charge shall inspect this vulnerable points and ensure there is no hindrance to flow of water during the monsoon.
