<u>Inspection Note</u>

- Comprehensive Development of Corridor (Outer Ring Road) between Mukarba Chowk to Wazirabad Chowk.

Inspected the site of Mukarba Chowk to Wazirabad along with EE, F-11, and Project Manager of M/s. CEC on 15.04.2016.

First, all the pending activities were reviewed and it was felt that a lot needs to be done in A-1 ramp where no WMM work was being carried out. Agency committed the following target dates: -

- ✓ A-1 ramp WMM work by 18<sup>th</sup> April' 2016
- ✓ Central verge kerb stones by 21st April' 2016
- ✓ BC on A-1 ramp by 21st April' 2016
- ✓ A-2 ramp merging de-merging area by 18<sup>th</sup> April' 2016 and DBM and BC by 21<sup>st</sup> April' 2016
- ✓ L.H.S. deck BC by 18th April' 2016
- ✓ R.H.S. BC by 15<sup>th</sup> April' 2016
- Expansion joints on R.H.S. by 20<sup>th</sup> April' 2016 and expansion joints on L.H.S. by 23<sup>rd</sup> April' 2016
- ✓ Grinding and painting of central verge/crash barrier by 23rd April 2016
- ✓ Crash barrier on expansion joint location by 24th April 2016
- ✓ Load test should also be carried out on priority.

It was felt that number of grinders for finishing of central verge crash barriers and graders for laying of WMM layers are on lesser side which should be enhanced immediately. The EE, F-11 was directed to monitor all the pending activities closely so that this flyover is opened to the traffic by the end of this month.
