# Inspection Report of Chief Engineer (North), PWD on 31-05-2016

The various roads and progress of desilting works on various drains under Shakur Basti Constituency were inspected by Sh. P. B. Singh, Chief Engineer (North)-M alongwith Sh. K. R. Bhandaria, Superintending Engineers (North-West) concerned Executive Engineers, Assistant Engineers, S.O. (Hort.) and others. Following were observed during inspection:

- It could be seen during inspection that in general the maintenance of the roads is in pathetic conditions inspite of the facts that Roads / Horticulture division are incurring huge expenditure in maintenance of roads.
- Even after the recent tragic i.e. fatal accident of child in nearby area under the jurisdiction of this division, many of the drain covers are open. There are large gaps in between concrete slabs placed on the drain. Situation is alarming because these drains are also designed as footpath on top. After the accident, cautionary advice and strict instructions were issued by Pr. CE (Maint.) as well as by undersigned but these have not yet be attended.

Not a single stretch of the road is in good condition.

4. Even small things which required little expenditure are not being attended. There are lots of bald surface with malba / garbage are littering on these spaces, which are supposed to be maintained green.

Some of the defects notices during inspection are listed on below. This is just to give the idea what our Engineers and maintenance staff are performing even after having a large numbers of engineers, huge team of maintenance staff / labour and number of maintenance vans.

## Road No.43 Started from Britannia Chowk towards Rani Bagh.

- Grill broken/tilted at places.
- Malba lying in Central Verge at Junction of Road No.44
- Footpath broken at various places

## At junction of Balbir Sing Siddhu Marg

- Bell mouth blocked; footpath damaged, Malba lying.
- Precast slab near community centre are uneven, manhole cover tilted
- Footpath broken
- Malba lying in entire central verge
- Footpath Paverblock settled down where howkers are standing.
- Pre Cast Road Slab tilted near urinal

## Near Shakurbasti Ralway entry

Kerb stone broken, paver block broken/missing.

- Footpath broken, Kerb stone broken
- Footpath settled down & coverd.
- Around trees edging for kuchaa portion be made surplus paver block lying on footpath.
- Malba laying in kerb channel

#### Near Ordinance Depot

- Footpath broken

- Malba lying in Central verge
- Wild growth on footpath

#### After junction of Road No.42

- Drain cover tilted
- Grill missing

## Near Bhagwan Mahavir Hospital

- Footpath broken
- Central Verge broken
- Kerb Channel not cleaned
- Wild growth on entire service road
- Large gap in precast slab at various places which should be fixed in proper line & level.

## Near Petrol Pump

- Different size slab have been fixed instead similar size.
- No. desilting work is going on Road No.43

## On service road

- Malba lying in entire stretch alongwith footpath.
- Wild growth on service road.

- Gap in RCC pre cast slabs
- Uneven level of pre cast slab
- Uneven and gap in RCC slab near Petrol pump
- Videographey of all desilting work of drain be done

- Drain covers uneven

# Road No. 42 (C.S. Azad Marg.)

Desilting material is lying on road side which should be removed.

Superintending Engineer (North-West) and Executive Engineer (North-West) Road-2 to make sure that works are taken on fast track mode and take immediate necessary action for properly securing / covering of nallah, manhole covers within 7 days of issue of this letter and submit the action taken report.
