

Following points were discussed:

- Hon'ble MLA Sh. Sanjeev Jha requested to expedite the work of widening and strengthening of Main Burari Road from Outer Ring Road to Burari More.
 Status - PE has been submitted to CE office on 14.06.2017 for Rs. 8.64 crores for A/A & E/S of competent authority.
- Hon'ble MLA requested to expedite the work of improvement of drainage system from Hiranki Bandh to Amrit Vihar and Swaroop Nagar to Burari creek. He also requested to expedite obtaining NOC from I&FC Department for construction of drain in their area.

Status - PE for Rs. 8.50 crores (appx.) has been prepared and shall be submitted to CE office within 15 days. CE instructed PWD officials to obtain NOC from I&FC Department at the earliest.

- 3. Hon'ble MLA requested to expedite widening of carriageway from Nathupura to Hiranki Bandh to ease traffic flow.
 - Status PE under preparation and shall be finalised within 10 days.
- Hon'ble MLA requested to expedite widening of culvert at Bangali Colony, Main Burari Road for decongestion of traffic.

Status - CE instructed to submit PE for A/A & E/S at the earliest as it has been delayed.

- Hon'ble MLA requested to expedite tree cutting permission from Dy. Conservator of
 Forest for in widening and construction of footpath on Main Burari Road.
 Status CE instructed to expedite the process.
- 6. Hon'ble MLA requested for plantation in central verge which require less water. He also requested to provide good earth in remaining central verge from Nathupura to Hiranki Bandh for plantation.
 Status CE instructed DD (Hort.) to fill good earth in remaining area of central verge. He also directed to plant bougainvillea in central verge in the monsoon period.
- Hon'ble MLA requested to expedite shifting of electric poles/ transformers from ORR to Burari More for widening of road.
 Status - CE instructed EE (E), CND Division to contact DERC personally to expedite vetting of estimate.
