## Inspection Note

Following works were inspected in presence of Sh. Rajiv Khare, AE and Contractor representative on 22.07.2017 and directions given for compliance:-

## 1) Construction of FOB at Sindhora Kalan -

- Progress of work is slow. Sh. Gaurav, Contractor's site Engineer mentioned that work shall be completed by 20.08.2017. Contractor to give completion schedule in this regard.
- ii) AE (E) requested for provision of a room for the purpose of panel board and operator rest room. EE, C&ND Road to take necessary action.
- iii) Lift should be provided with lock and key.

## 2) Accessibility work being executed on the footpath at University Campus -

- i) Steel railing provided are not slanting and are fixed at a distance from the start of ramp. This is rejected. Proper railing should be provided as per convenience to differently abled persons and proper ramp should be provided to footpath for the smooth passage of wheel chair.
- ii) Welding of railing is not proper, it may be rectified. Finishing are not smooth.
- Dotted tectile tile should be provided whenever there is change of direction/hindrance. The tectile tile should be continued throughout the footpath without any abrupt end.
- iv) Joints are not properly finished in red sand stone being provided at footpath.
- v) It should be ensured that approved brand of tectile tile is used at site.
