## INSPECTION NOTE

LG House was inspected on 29.08.2017 along with concerned EE, AE, JE and representative of contractor. During inspection following directions were given:-

## A. Inspection of LG House

- Near Dhobi Ghat, electrical chamber was covered with broken stone slab. It may be replaced with chequered plate/suitable material keeping the electric cable inside the chamber. Action: EE (E)
- Horticulture/Electrical workers were not wearing PWD uniform while working inside the campus. It may be ensured by DDH/ EE (C)/ EE (E).
- Any dismantled waste of Civil, Electrical and Horticulture should be removed immediately.
   Action : All EE/DDH
- Sun shade is still to be provided to the geysers placed on the roof. This may be done by 10.09.2017. Damaged sheet of old sun shade should be replaced and painting to the stand may be done.

  Action : EE (C)
- It was requested by AE(E) to remove mid wall from the AC plant room near PS to LG Chamber for the replacement of AC plant.
   Action : EE (C)/EE(E)
- Solar panels are to be provided on 10 No. electric poles. The existing solar water heater system provided on the roof-top of electric sub-station may be replaced with new solar plant of 10KW as per discussion held with PS to LG.

Action : EE (E)

- 7. For the replacement of AC plant near conference room an temporary opening is to be made in the wall of AC Plant room.

  Action: EE (C)/EE(E)
- Stagnation of water at main entry of LG House is still to be attended by EE(C). It
  is getting delayed.

  Action : EE (C)

## B. Inspection of Reception Building

- RO system of suitable capacity shall be provided on the roof-top along with water cooler. Cool drinking water shall be supplied in the building from this RO system. Insuation to pipes may be done accordingly. Action:EE (E)/EE(C)
- 2. Insulation of copper pipe is not proper, it needs to be insulated properly.
