Inspection Note

Ms. Abha Negi, Accessibility Consultant visited University Campus roads on 06.09.2017 relating to road accessibility and safety. During the inspection, following directions were given:

- Tactile should be provided in continuity. Linear tactile should be provided along the straight path involving no change in direction. Dotted tactile should be provided whenever there is change in direction.
- 2. Pruning should be done where trees / plants are obstructing the path, sign board etc.
- 3. Footpath at the entrance of College / Institution should be raised for maintaining the level of adjoining footpath by providing ramp (1:10) and drainage pipes. For providing table top on the main carriageway the slope of ramp can be 1:8.
- 4. Cover slab to manhole should be at the matching level of footpath.
- 5. Sign board should be provided after 1 feet from the footpath edge towards carriageway. Height of sign board should be more than 8 feet from the ground.
- **6.** For the informatory sign board, Ms. Abha Negi suggested for cantilever bigger sign board for the convenience of public.
- 7. Red sand stones kerb stones provided at University Road should be painted black & white for clear visibility.
- 8. Zebra crossing, lane marking, speed calming measures, delineators, solar studs etc. should be provided.
- 9. Proper nosing should be provided where the road bifurcate.
- A sample stretch is to be developed incorporating the above features within 20 days.
- 11. At the visit to FOB, Sindhora Kalan, Ms. Abha Negi suggested the following :
 - a) Flamed granite may be used in place of polished granite.
 - b) It would be better if nose of different colours is used in the step or groove at nosing may be provided with different colour for identification of steps.
 - c) Tactile (Guide & Warning) to be provided at the landing and deck slab as discussed at site.
 - d) Railing at lower level is also to be provided at stair case and deck slab for the convenience of children and specially abled persons.
 - e) Lift should be provided with facility to visually and hearing impared person.
