INSPECTION NOTE

CE (East) carried out inspection on 23.09.2017 of area around Raj Ghat as function is to be held on 02.10.2017 in which high dignitaries will participate. Following officers were present in the inspection :-

- 1) Sh. Mukesh Kumar, SE (C&ND).
- 2) Sh. Anil Trehan EE(C&ND) Road.
- 3) Sh. Sanjay Verma, EE(E), DHC/ND.
- 4) Sh. Vijay Kumar, DDH (East) and feild staff.

In the inspection, following directions were given :-

(A) Main gate of Raj Ghat, Ring Road

1. Road gully chamber in front of main gate of Raj Ghat should be repaired.
2. DBC on service road, footpath and drain repair should be carried out before 02.10.2017.
3. Kaccha portion on the side of service road – Grass paver may be provided.

(B) Kisan Ghat Road

1. Area of rumbled strip should be increased.
2. Damaged cobble stone and footpath should be repaired.
3. In the central verge, ground cover should be increased by Horticulture Unit.
4. Plantation be done to increase greenery.
5. Sign board provided at the entry of Kisan Ghat Road from Raj Ghat is not visible and information is also incorrect. The board should be placed at the visible location with the correct information.
6. Pedestrian sign board should be provided at the zebra crossing.

(C) Raj Ghat intersection

1. Accesibility should be increased on the footpath for the specially abled persons. At zebra crossing, cut may be made in the central verge for smooth walking.
2. Service Road near main gate, Raj Ghat – Footpath should be extended as discussed at site.
3. Miscellaneous – Footpath, drains, toe-wall, gully chamber etc. at the main gate of Raj Ghat should be improved for giving aesthetic look keeping that foreign dignitaries visit the area.
