Flyover to Hanuman Setu), Ring Road Bypass, DDU Marg, Minto road, Asaf Ali Road and BSZ Marg on 23.10.2017. After the inspection, a meeting was also held by E-in-C. Inspection and meeting was attended by following officers:-

In the meeting and inspection, following directions were given:-

- 1. Beautification of area below I.P. Flyover is to be completed within 15 days as LG is to visit the area.
- 2. Work is to be undertaken on emergent basis including Civil, Electrical and Horticulture works; progress to be monitored on daily basis (All SEs).
- 3. Existing street scraping work below I.P. Flyover should be repaired wherever required. Gap filling may be provided in the Horticulture Work. Anti carbonation paint should be done under the flyover in the first phase.
- **4.** An unauthorised temple is there below I.P. Flyover. Matter should be taken up with Religious Committee for its removal.
- 5. Pump House and JE Office at I.P. Flyover Unserviceable material should be removed and stored material should be shifted. Footpath, building etc. should be repaired and painted properly. Complete area is to be developed with green features. The Pump house & the JE office should be integrated with the developed area.
- **6.** I.P. Police Station Unauthorised vehicles are parking on the road. Matter may be taken up with police for their removal.
- 7. Horticulture work needs to be improved from I.P. Flyover to Red Fort. Marry Gold plant may be provided on both sides of this Road.
- 8. Minto Road to Asaf Ali Road Road is in bad condition.
- 9. Round about at Asaf Ali Road A fountain or any other beautification work may be provided to beautify the area.
- 10. Malba on Asaf Ali Road Matter may be taken up with North MCD.

- 11. Island near ISBT The area may be provided with iron grill/RCC grill.
- 12.E-in-C directed that 50% work should be completed within 1 week. The site will be inspected by E-in-C after 1 week for review of work.
- 13.Individual SEs shall be the nodal officer for the development works to be done under their jurisdiction.
