INSPECTION NOTE

Sub: Inspection undertaken by CE(East) on 08.12.2017 under C&ND Road Division.

CE(East), PWD carried out Inspection of C&ND Roads on 08.12.2017 along with the following officers:-

- 1) Sh. Mukesh Kumar, SE (C&ND).
- 2) Sh. S.K. Garg, EE(C&ND) Road.
- 3) Sh. T.P. Singh, DDH (East).
- 4) Sh. V.K. Garg, AE(C&ND) Road.
- 5) Sh. D.N. Gupta, AE(E), DHC&ND/Central (M-451).
- 6) Sh. Shyam Singh, ADH (East).

During inspection, following directions were given:-


1. **Minor Engineering Works to be undertaken for NCAER** – Area should be properly surveyed along with proposed scheme. Matter is to be referred to UTTIPEC for their approval.
2. **Azad Bhawan Road** – Area may be surveyed and proposed scheme for development of footpath may be submitted to CE for perusal.
3. **I.P. Flyover** – Greenery may be improved in the central verge. Dustbin needs to be provided. There should be no encroachment in the area and no unauthorised person should be allowed to stay in Pump House or in any other area. Sign board may be provided mentioning "Silence Please", "Do not litter". Details of malis, security guard, pump operator etc. should be displayed at Notice Board at Pump House. Notice to temple is to be given.
4. **Art installation at I.P. Flyover and Gulab Vatika** – Focussed light may be provided.
5. **Samta Sthal** – Footpath needs repair. Missing drain cover to be provided. DJB over flow was observed which may be got attended. Green area near tree may be provided with edging.
6. **Service road near Samta Sthal** – Malba needs to be removed. Practice of making mortar on road should be stopped.
7. **JLN Marg** – Footpath needs to be repaired.
8. **Hanuman Setu** – Painting of kerb stone is being done without cleaning the surface.
9. **ISBT U-turn** – Footpath/toe wall needs repair, proper sign for merging traffic should be provided at U-turn.

10. Subway extension – Curing not being done properly. Bulging of RCC wall was observed due to improper shuttering. The work needs to be expedited so that additional lane could be made available to traffic. Existing gantry sign board needs to be redesigned to accommodate additional lane. Completion programme is to be submitted by EE/Contractor.

11. Salimgarh underpass – Encroachment of shop should be removed.


12. Old Iron Bridge – Sign board and road marking are missing.
