Inspection Note

CE (East) carried out inspection of Ring Road from Bhairon Marg X-ing to Rajghat X-ing. Inspection was attended by the following officers:-

- 1) Sh. Mukesh Kumar, SE (C&ND).
- 2) Sh. S.K. Garg, EE(C&ND) Road.
- 3) Sh. T.P. Singh, DDH (East).
- 4) Sh. V.K. Garg, AE(C&ND) Road.
- 5) Sh. D.N. Gupta, AE(E), DHC&ND/Central (M-451).
- 6) Sh. Shyam Singh, ADH (East).

During the inspection, following directions were given:-

- Bhairon Marg X-ing Bollards are broken. SE (South East) to take necessary action.

 The state has been banded.
- 2) Bhairon Marg X-ing to I.P. Metro Station The stretch has been handed over to ITPO Project Unit. CPM, ITPO is requested to provide barricading along the road immediately as ASEAN Meeting is to be held shortly.
- 3) Malba/loose material may be removed near Bhairon Marg X-ing. Action to be taken by EE (C&ND) Road Division and EE (South East) Road Division.
- 4) Bhairon Marg X-ing to I.P. Metro Station Horticulture Unit to maintain the greenery properly with pruning and cleaning wherever required.
- Railways has constructed its workshop in- the ROW of PWD. Letter may be written by EE (ITPO Project Divn.) to Railways in this regard.
- 6) NBCC is making foundation for the sign boards in the ROW of PWD Road. ITPO Project Unit to check whether permission has been given by them in this regard. NBCC should construct any foundation and sign board within the boundary wall of ITPO and not in the ROW of PWD Road.
- 7) A petrol pump is under construction near I.P. Depot and a dhalao is being shifted. EE (ITPO Project Divn.) to check whether permission has been given in this regard.
- 8) Bhairon Marg to Raj Ghat X-ing Schedule of water tanker (Civil & Horticulture) to be fixed for proper monitoring.
- 9) PWD logo to be provided on the grill installed at the central verge.
- 10) I.P. Flyover Contractor has not painted crash barrier with approved colour scheme. Yellow colour scheme is not acceptable. Necessary action may be taken by EE.
- At Start of Ring Road Bypass Proper nosing may be provided with reflecting bollard.

12) Raj Ghat X-ing

- (a) Zebra x-ing, lane marking, kerb stone painting may be provided immediately wherever required and missing. Necessary direction has been given at site in this regard.
- (b) Rumble strip may be provided at the turning.
- (c) Nosing may be repaired at Rajghat X-ing.
- (d) Delineator has not been fixed properly.
- (e) Some of the area require jungle cleaning and malba removal.
- (f) Zebra x-ing is missing at the turn. May be provided immediately.
- (g) Potted plants may be provided at the central verge and at the island as discussed at site.
- 13) Some grills are missing at the BSZ Marg.
- 14) Before zebra x-ing, "stop" sign may be provided and speed calming zone may be provided.
- JLN Marg Old sign board may be removed.
- 16) Pedestals of street pole, sign board may be painted immediately.
- 17) In general, missing kerb stone, footpath stone etc. be attended to immediately.
- 18) Brick Wall is under construction near Feroz Shah Kotla Stadium near service lane towards ITO from JLN Road. EE (C&ND) Road to check who is constructing and whether approval has been given by PWD. If it is unauthorised, it may be stopped immediately and demolished.
