Inspection Note

University Campus was inspected on 01.02.2018 by the undersign along with Sh. Vipin Tiwari, OSD to V.C, Delhi University. Inspection was attended by the following officers:-

- 1) Sh. Rajiv Khare, AE (C&ND) Road.

During the inspection, following observations were made:-

- Shreya Mishra Marg OSD mentioned that light is insufficient on this road. Due
 to trees, proper light is not available at the ground. It was proposed to provide
 double bracket on the existing street pole for better illumination. Action: EE(E)
- GTB Road Kerb channel have not been repaired. Footpath is broken in front of V.C House. Action: EE(Road)
- 3) OSD requested for removal of encroachment by taking the matter with STF/MCD.

 Action: EE(Road)
- 4) Road marking needs improvement as it has become black at number of places. OSD requested for coble stone flooring in front of college gates for safe pedestrian movement. EE (Road) to make estimate in this regard for obtaining A/E & E/S.
 Action: EE(Road)
- 5) Chatra Marg OSD requested for development of this road as Model Road with proper lighting, greening, road marking and civil works. Action: EE(Road), DDH, EE (E).
- 6) At the entry and exit of footpath, proper ramp should be provided. Whenever length of footpath is more then 100 M, ramp/approach to footpath should also be provided in the middle of footpath.
 Action: EE(Road)
- 7) Some abandoned bolts were seen in the road/footpath which may be removed. OSD requested to provide solar studs, spring post, delineators, bollard on the roads for improvement.
 Action: EE(Road)
- 8) Tilted pole was noted at University Road (Stephen College staff quarter gate).

- 9) OSD observed that manhole cover/slabs are generally projecting out from the footpath which is inconvenient to physically challanged persons. He requested for providing smooth manhole covers at footpath level. University Road Footpath needs to be repaired.

- 10) Bus stop at University Road Steep ramp has been provided which may be reduced.

- 11) University Road OSD requested to make University Road as Model Road on account of heavy pedestrian traffic.
