# INSPECTION NOTE

Inspection of LG House was done on 07.06.2018. Inspection was attended by the following officers:-

- (i) Sh. S.K. Mandal, EE, LG House
- (ii) Sh. U.K. Sharma, DDH (East)
- (iii) Sh. Subhash Chand, AE
- (iv) Sh. Narendra, AE (E)

During the inspection, following directions were given:-

#### A) Gate work

#### 1. Civil work -

- (a) Connection of old brick wall and new brick wall has not been done properly. Same to be rectified immediately.
- (b) Proper joint filling of brickwork is not being carried. EE/AE to ensure the same. If any work found in this way, same should be dismantled. The progress of gate work needs to be expedited.
- (c) Sample of stone cladding has been approved. Material should be brought at site urgently. Stone jali as per drawing should also be procured in time.

#### 2. Electrical work -

(a) Guide rail for one gate has been provided. It may be provided to the other gate also keeping the layout and alignment in view.

### B) Staff toilet

- Damaged door/window, shutter etc. may be removed. Renovated toilet should give a new look.
- 2. Sloping terrace of staff toilet should be painted in terracotta colour.
- 3. At the steps, granite may be provided.
- Water from waste pipe of AC is damaging chajja at number of places. AE(E)
  was directed to provide proper disposal of AC waste water.
- 5. Work should be completed by 15.06.2018.

## C) Meeting with PS to LG

- Malba needs to be removed from the site of construction of toilet to officers. The work should be completed by 20.06.2018.
- While making entry from PS room to new toilet, the room should be vacated on holidays and work be carried out accordingly.
- Rain Water Harvesting Only one pit needs to be provided in place of 3. Same is to be approved from Delhi Jal Board.
- 4. Water Recycle PS to LG mentioned that LG desired to have Water Recycle Unit in LG House. Feasibility study needs to be done in this regard by PWD. EE(C) to take necessary action in this regard at the earliest.

Faulty light should be replaced with LED lights wherever required.

 Conference Room – Light is insufficient. AE (E) suggested that normal tube light should be replaced with LED tube light. It shall be done within a week.

#### D) Inside LG House campus

 At number of places, dry leaves/unwanted material was seen in green area, DDH was directed to regularly clean green area and potted plants.

2. In this hot season, special care needs to be given to plants to avoid damage.

 Back gate of LG House – Boundary wall needs repair at some places and should be white washed wherever it is giving shabby look.

 Near the main entry in the green area, red sand stone may be provided in the kaccha portion on pedestrian path as Hon'ble LG uses this path in morning walk.
