Sub: Inspection of East Road Maint. Sub Divn. M-2122.

The site of Sub Divn. M-2122 under East Road Maint. Divn. M-212 inspected alongwith Executive Engineer, Assistant Engineer and Junior Engineers on 21.08.2019. The following observations were found during the inspection.

A. Desilting Work (for Section No.-2):

- The desilting work of drains is being executed for Section-1 & 2. During review of records / registers of the work, it was noticed that silt disposal slip dt. 08.05.2019 bearing No. 107464, whereas slip dt. 11.05.2019 is bearing No. 107438, which are not seems to be in order. EE to investigate and report.
- ii) Hindrance Register No hindrance entered till date.
- iii) Site Order Book No compliance recorded against each instruction written in Site Order Book upto Sl.No. 8.
- iv) Log Book- Reviewed.
- v) Mile stone: EE to ensure while making payment to agency regarding achievment / non-achievement of milestone and take necessary action as per condition of contract.

As per Clause-12 of the agreement, the total cost of work done should not exceed by 1.25 times of Contract Value.

As per Clause 36 of the agreement, agency is to deploy technical representatives. No any record shown by the Field staff. Agency present during the inspection told that he has not submitted the documents of technical representatives with the Deptt.

Monthly Progress Report not available with the AE/JE. Field staff told that agency has not submitted Monthly Progress Report. EE may ensure to recover the amount as per agreement condition.

EE may also check the non-availabilty of the super sucker machine during the work and take necessary action as per conditions of Contract. As per conditions of the Contract, the agency will submit three digital photographs – one for start of the work, second for middle of the work and third for completion of work of the day. No any record shown by the field staff with regards to digital photographs. EE to ensure maintaining of such records in terms of agreement conditions.

- vi) Details of GPS systems installed at Super sucker machine not available with field staff.
- vii) No record available, which can show removal of floating material of the drains.

The site of desilting work was also inspected and it was found that silt has not been removed from the drain side for the long time and there are chances that during the rain the silt will again fall down into the drain.

B. C/o RCC drain at Budh Ram Singh Marg & Sameer Bhan Marg:

During the inspection of work, agency informed that work has been stopped due to a temple coming in the alignment of drain. The Executive Engineer was directed to check the length of drain which can be constructed and also take measures to execute the drain passing in front of temples since the work had been delayed. The following documents / registers for the above work were also reviewed.

- i) Inspection Register: Not maintained by the field staff.
- ii) Cement Register: Reviewed.
- iii) Hindrance Register: Reviewed.
- iv) Site Order Book Reviewed.
- v) MAS Register: Reviewed.

C. <u>Widening of Road No. 102 from Bharti Public School to Dallupura Road & Improvement of Kaccha Portion on Porta Cabin Road</u>:

i) No any document / register produced by EE / AE / JE. Executive Engineer may clarify.

After reviewing the documents and inspection of site it seems that the field staff is taking very casual approach for maintaining the records and execution of works.

Executive Engineer may submit the report for the above observations to this office.
