INSPECTION NOTE

Name of work: Construction of Mother and Child Block and Screening OPD Block at Dr. BSA Hospital at Rohini, Delhi including water supply, sanitary, installations, Electrical Installations, HVAC, Low Side Fire Alarm and Fire Fighting System etc.

The subject work was inspected on 25/01/2021 by the undersigned and the following has been observed and corrective action shall be taken:

1. The work of excavation of balance area for raft foundation has not been taken up. This will delay the work abnormally and the responsibility of making necessary arrangements lies with the contracting agency. The efforts shall be made to start the excavation by 27/01/2021.
2. Though the quality of concreting in columns is satisfactory and to further improve the quality of concreting in columns, the arrangement of shutter vibrator may also be made.
3. The starter of lift was casted and it was of very poor quality, the same shall be dismantled and redone.
4. The plumbing and drainage drawings were reviewed, the arrangements of cut-outs in the RCC wall shall be made to avoid any seepage from these places. The puddle flanges shall be provided at the appropriate places.
5. The issue of conduiting at surface level may be discussed with Executive Engineer (E) considering the agreement provisions.
6. The fire pipe line work may be reviewed by Executive Engineer (E), so that the necessary inlets at required points can be provided.
