GTB Hospital:

The earth work, RCC foundation and pedestals erection of steel structure was in progress.

During the inspection, the following points were observed:

1. It was found that at some places in RCC pedestals, the concrete was honeycombed and were not in line and level. These pedestals needs to be dismantled and to be recast again. The EE/AE should ensure proper concreting of RCC work.
2. On random inspections of the fabricated steel columns and beams available at site, it was found that the welding was not proper in some of the members. Either the size of the welding was not uniform, major pin holes, missing welding at the corner joint with gusset plate, deposition of the flux on members and welding etc.

All the defective welding pieces to be rejected and replaced. The EE should ensure that the proper welding is done in each and every member. The pre-inspection and final inspection of the fabricated members are to be done at the factory as well as site. The members not having the proper welding should be rejected and replaced.

3. Only 1368 numbers of steel structure members has been fabricated and 224 numbers has been erected against approximately 5000 numbers. The fabrication and the erection of the steel members to be expedite.
4. The progress of pending excavation and foundation / pedestal is also on slow pace needs to be expedite.

CNBC Hospital:

The erection of steel structure was in progress.

During the inspection, the following points were observed:

1. On random inspections of the hollow steel columns and beams, it was found that the welding was not proper in some of the members. Either the size of the welding was not uniform, missing welding at the corner joint with gusset plate, deposition of the flux on members and welding.

All the defective welding pieces to be rejected and replaced. The EE should ensure that the proper welding is done in each and every member by pre-inspection and final inspection of the fabricated members at the factory as well as site.

2. Only 1442 numbers of steel structure members has been fabricated and 244 numbers has been erected against approximately 3278 numbers. The fabrication and the erection of the steel members to be expedite.

The progress of the work is very slow and the contractor may be asked to expedite the progress of work by deploying more resources like machinery for erection i.e. cranes & hydras, man & materials and start the other activities.
