During inspection following observations were made.

1. In the ramp portion, at Moti Nagar Crossing flyover and Punjabi Bagh Flyover, it seems that for earth filling proper compaction is not being done. Agency is directed to do compaction in layers so as to achieve desired MDD at site.

[Action :- Agency, EE/F11, AE/F-111 & AE/F-112]

2. Some of the RE panels of the ramp are not properly finished. Agency to take extra care for proper finishing of panels, and ensure that sides and edges don't get damaged.

[Action :- Agency, EE/F11, AE/F-111 & AE/F-112]

3. Agency to provide sufficient safety measures, for movement of vehicular traffic and pedestrian. All workmen to be provided with PPE kits, while working.

[Action :- Agency, EE/F11, AE/F-111 & AE/F-112]

4. AS discussed during inspection, agency to provide the following :-

- (a) CCTV Cameras at site
- (b) 3-D Model of the Project
- (c) Anti-Smoke gun at site
- (d) Completion programme

5. As the rains has started, the agency to ensure that no water-logging should be there on road. Also, pot-holes, ruts on road surface be promptly attended and rectified for convenience of commuters.

6. At some places, it was seem that steel reinforcement bars seused rusted. Agency to make arrangement for proper stacking arrangement and anti-rust treatment for the reinforcement bars.

7. Approval of the various materials like bearing, deck sheets etc. as mentioned in the agreement has invariably is be taken from competent authority. Factory visit of supplier is to be arranged. Credentials of the suppliers has to be submitted before hand.
