During inspection following observations were made.

# 1. Subway near Moti Nagar Crossing at Punjabi Bagh Flyover,

As discussed during the inspection, the agency will make the drawing of proposed subway and submit it for approval to competent authority. The agency will shift all utilities from the alignment of proposed subway. The electric pole coming directly in front of staircase needs shifting. (Action: - Agency & EE and AEs PWD)

# 2. Point No.2- Regarding shifting of utilities.

The status report of utilities is to be submitted in tabular form conataing how many utilities have been shifted, how many are still to be shifted. Brief details to be provided along with coordination done with concerned department for shifting the balance and upcoming utilities. It is to be submitted by 11.07.2023. (Action:- EE, PWD)

3. Agency to provide all safety measures, for movement of vehicular traffic and pedestrian. All workmen to be provided with PPE kits, while working, so that any untoward incident can be avoided. (Action: - Agency & EE and AEs PWD)

## 4. Regarding repair of old damaged steel bridge made on NG drain.

EE to provide the details for temporary strengthening of existing damaged portion of steel bridge for approval of competent authority. EE has first to check how many cables were allowed to be shifted initially and how many cables are currently on the bridge. An undertaking must be taken from TPDDL that the existing damaged bridge will be repaired once, after that the TPDDL will be responsible for its future maintenance. No work shall be started before obtaining undertaking. Submit a draft undertaking for approval. (Action: - EE PWD)

- 5. Agency to provide the sufficient barricades in proper alignment and all barricades should be painted /cleaned as per agreement provision, so that any untoward incident can be avoided. (Action: Agency & EE and AEs PWD)
- 6. During the monsoon potholes are being formed and road may get damaged. In view of this agency shall deployed the separate teams at different places, so that road can be repaired simultaneously. (Action: Agency & EE and AEs PWD)
- 7. There should be no cost of time escalation in the project. (Action: Agency & EE and AEs PWD)
