The following observations were discussed:

#### FoB in front of Supreme Court of India

1. Progress Work is slow and lifts are yet to be installed. EE (E) is directed to take action against the agency as per terms & conditions. The granite flooring is cracked at many places. It is to be repaired / replaced. [Action – Agency, EE(E), EE(C)/AE ITPO].

#### FoB in front of Zoo and Bharion Road

2. These are to be maintained as per SOP. Escalator are to be made operational. [Action – Agency, EE(E), EE(C)/AE ITPO]
3. It was directed that the work is to be carried out with all safety precautions and avoid any lapses. Responsibility of any lapse shall be of executing agency. Directions issued by Secretariat in this regard must be followed in letter and spirit, [Action, Agency, EE (E)/EE(C)]
