Following observations were made during the inspection:-

- 1. Progress of the flyover at site was reviewed and concern is expressed regarding progress of work & missing of targets. (Action:- Agency, EE, AE)
- 2. Overall maintenance of site is poor. There are very few barricading boards. Malba is lying at site. Kerbs and footpath are in dilapidated condition. This work is on route of G20 summit and any laxity is unacceptable. Hence work is again advised that it is to be given utmost importance and in case of default action should be taken as per terms and conditions of the agreement. (Action:-Agency, EE, AE)
- 3.
