During the inspection, the following has been observed: -

1. Progress of work was reviewed, it was appraised that Piling, Pile Cap & Pier Cap work in progress. Agency was asked to improve the pace of work and directed to match the progress as enumerated in work programme. (Action: - Agency, EE, AE)

2. The Casting yard and plant site was visited, lab area and various registers were reviewed and it was directed to do all testing and to be recorded as per QAP plan and shall be produced for perusal from next visits onwards. (Action: - Agency, EE, AE)

3. Safety issues:- Reflective tape to be provided for smooth movement of traffic. Workers & Engineer deployed at site should be with all safety equipment. Appropriate lighting arrangement should be provided for smooth movement of traffic during night period. At all active site location should be barricaded properly to avoid any accident at site. Sufficient Marshalls should be deployed at junction around moving machinery/ equipment for safe movement of road users. (Action: - Agency, EE, AE)

4. Agency was also asked to provide the marshals/arrangement as per agreement provision for smooth movement of pedestrians and vehicle at junctions and crossing

point. (Action: - Agency, EE, AE)

5. It was also pointed out that suitable dust mitigation measures shall be taken as per

agreement provisions. (Action: - Agency, EE, AE)

6. Agency to adhere to all safety guidelines as per agreement, CPWD Works Manual codes, Good structural engineering practices & as issued by GNOTO,;*10.No. 4(60)/23-24/PWD-II/Roads (CD No 057742583)11054-47 dated 11.0,a Responsibility of any violation shalt be of executing agency & EE should take action as per guidelines for any violation.
