## निरीक्षण नोट

Inspection of Additional half flyover at Sarai Kale Khan T- Junction was carried out by Hon'ble Minister (PWD) on 07.08.2023. The inspection was attended by the officers etc. as per Annexure-I. In the inspection, following directions were given -

- 1. Hon'ble Minister reviewed the progress of flyover at site and expressed displeasure in the slow progress of work & missing of target.
- 2. Engineer-in-Chief, PWD apprised the Hon'ble Minister regarding critical delay in casting of 50m span slab due to unprecedented rains, traffic police permission & other miscellaneous reasons. Hon'ble PWD Minister was also intimated about traffic jam along the site during working hours.
- 3. Hon'ble PWD Minister directed to complete the casting of balance slab by 17.08.2023 and completion of flyover by 15.09.2023.
- 4. Chief Engineer (Flyover) shown the Art work proposal to Hon'ble PWD Minister for approval. Hon'ble PWD Minister directed to modify the proposal showing Madhubani painting below flyover.

5. It was directed to follow all safety precautions and avoid any lapses. Responsibility of any lapse have to be bear by the agency.
