During inspection, following items were discussed:-

- 1. It was appraised that site layout plan was already got approved from client department i.e. Transport Department. It was directed to keep A1 size of drawings of all plan and structural drawings at site.
- 2. It was appraised that design and drawings were sent to 3rd party for vetting. It was directed to get all the drawing vetted at the earliest.
- The execution of work involves huge quantity of municipal solid waste disposal.
 Agency was directed to strictly follow disposal norms as per agreement and relevant codes.
- 4. The excavation work was in progress. It was directed to check the levels of ground before and after excavation and same shall tally with established benchmark and approved drawings.
- 5. It was appraised that approx. 1 m earth work excavation & its disposal is executed as per requirement of agreement, however CBR value for pavement design at this level is not coming out to be satisfactory as per codal provisions after testing

done by NSUT. Accordingly, NSUT was requested to provide detailed design of sections as per CBR and Codal provisions. Structural consultant was directed to design pavement accordingly.

6. AEE and EE were directed to calculate amount of further excavation required and calculate financial implication arising out of this excavation and intimate it to transport department if it is exceeding the sanction amount. In principle Approval of deviation and financial implication should be taken in advance from competent authority.
