During inspection, following items were discussed: -

- 1. The undersigned appreciated the finishing of completed works overall quality of works. The efforts of Sh. Karthik R., PM and all the team of M/s L&T are commendable in this aspect.
- 2. Progress of work was reviewed and it was instructed to expedite progress to complete the work within given time-frame.
- 3. Sh. Karthik R., Representation of L&T raised a concern regarding contractor's cash flow caused by project prolongation, unprecedented price rise and nonpayment of pending arbitration award. It was informed that the progress of work cannot be linked with payment of arbitration award. In case of delay necessary action shall be taken as per T&C of the agreement for the delays on part of the agency. Furthermore, it is to be noted that Running bills are being paid on time.
  - 4. Agency to adhere to all safety guidelines as per agreement, CPWD Works Manual, Safety codes, Good structural engineering practices & as issued by GNCTD vide No. 4(60)/23-24/PWD-II/Roads dated 11.07.2023. Responsibility of any violation shall be executing agency & EE should take action as per guidelines for any violation.



- 5. L&T casting yard site is to be kept clear and no construction malba is to be lying unattended. The vacant land is to be returned to DDA in the pristine condition.
- 6. Tree cutting is the critical activity and it is to be taken up at higher level.
