

During the inspection, following issues were discussed and decided -

- 1. Agency was instructed to speed up the work and to provide sufficient anti-smog gun.
- 2. Retaining wall along nallah to be speed up and to be completed by 30.12.2023. so that BSES may initiate shifting work.
- 3. Agency to ensure proper compaction of ramp, proper joint sealer and parapet of RE wall.
- 4. At site, few workers were without safety gear. Agency and site staff to follow safety guidelines as per agreement and CPWD manual.

- 5. It was directed to provide sufficient number of night blinkers & reflective signages at night to prevent any accident at site due to fog.
- 6. Agency to expedite the work of hump subway and retaining wall to complete by 20.12.2023 for smooth movement of traffic.
