During the inspection, following points were discussed and decided -

- It was informed that out of total pile 186 available scope, only 5 piles are left to be casted. Pile cap and pier work is in progress.
- 2. EE F-21, Sh. Tejsingh Meena informed that land measuring approx. 6300 sqm has been recently awarded by DM (South East) office which will be handed over to the agency by next week.
- Representative of L&T, Mr. Kartik R mentioned that sinking of LRP04 well is now complete and bottom plugging is under progress. Agency was directed to complete the bridge portion at the earliest.
- 4. APP membrane fixing was in progress at LRP main bridge. Proper fixing of APP membrane is to be ensured at site. APP membrane should be as per specification and necessary test need to be carried out. Mr. Kartik R, Representative of L&T, informed that DBM over APP membrane will be taken up soon.
- 5. Safety precautions and pollution control measures need to be taken as per guidelines without any compromise.

Accordingly, all concerned are requested to take action.
