Following observations are made & directions given: -

- 1. structural details of gantry structure to support of BSES cables is to be submitted by agency. These must be done on priority.
- 2. It was directed that structural designer may explain the drawings submitted by the agency. The action is awaited.
- 3. The work of ramp on ROB side and widening of adjacent road to be expedited.
- 4. Hon'ble Minster PWD in her visit on 06/12/2023 directed to close the cut at P1 & provide U-turn. It is observed that steel girders are lying on this location. These may please be assembled & launched at the earliest so that U-turn may be made fully functional.
- 5. Agency to adhere to all safety guidelines as per agreement, CPWD Works Manual, Safety codes, Good structural engineering practices & as issued by GNCTD vide No. 4(60)/23-24/PWD-II/Roads (CD No. 057742583)/1054-47 dated 11.07.2023. Responsibility of any violation shall be of executing agency & EE should take action as per guidelines for any violation.
