Following observation were made during inspection:-

 Agency is directed to submit the Electrical drawing / layout plan along with load calculation as soon as possible so that case can be applied to the concerned department for electricity connection. Sh Gaurav said that they will submit it within 2 days.

- 2. Agency is directed to submit the details related to painting and art works of each flyover as soon as possible for advance action. Sh Gaurav said that they will submit it within 2 days for Moti Nagar flyover.
- 3. The agency is directed to expedite the balance work of Moti Nagar Flyover like slab casting of middle spam, fixing of bearings, W-4 crash barrier, bitumen work of ramps and fitting of electrical poles etc. so that flyover work can be completed within scheduled time.
- 4. The work of widening of existing Moti Nagar Flyover is to be completed as earlier as possible, so that flyover work can be completed within scheduled time.
- 5. The decision for the shifting of FOB has already been given to agency to remove the same immediately. It will enable to complete Moti Nagar Flyover can be completed within target schedule time and as per instruction given by Hon'ble Minister, PWD.
- 6. Agency is directed to make arrangements for exit at down ramp, of Moti Nagar Flyover near FOB, as per UTTIPEC approved drawing and completes the balance part of RE Wall.
- 7. Damaged road, pot holes etc. must be repaired urgently to ensure smooth traffic flow.
- 8. Agency to submit the details of plantation at grade level under both flyovers. The details of Sarai Kale Khan flyover maybe followed for guidance.
- Agency is directed to deposit money as intimated by Executive Engineer, F-11, with different departments i.e. BSES, TPDDL, DJB, for timely removal / shifting of utilities, so that any delay in completion of the project may be avoided.
- 10. The existing central verge / median under and between the both flyovers may be made as per drawing or as per existing site condition.
- 11. Dust-control measure should be made effective by regularly using anti smog gun, sprinkler, covering of building material, removing of malba etc.
- 12. Agency to adhere to all safety guidelines as per agreement, CPWD Works Manual, Safety codes, Good structural engineering practices & as issued by GNCTD vide No. 4(60)/23-24/PWD-II/Roads (CD No. 057742583)/1054-47 dated 11.07.2023. Responsibility of any violation shall be of executing agency & EE should take action as per guidelines for any violation.
- 13. It is directed that all measures are to taken to control air pollution. Responsibility of any violation shall be of executing agency & EE should take action as per guidelines for any violation.
