

During the inspection, it is found that bearing replacement work is in progress on Pier no. 31 of right loop of Yudhister Setu. The following points were discussed: -

- 1. The Agency is asked to deploy the more manpower to complete the crash barrier work on river portion of right loop and main bridge.
- Agency to adhere to all safety guidelines as per agreement, CPWD Works Manual, Safety codes, Good structural engineering practices & as issued by GNCTD vide No. 4(60)/23-24/PWD-II/Roads dated 11.07.2023. Responsibility of any violation shall be executing agency & EE should take action as per guidelines for any violation.

- 3. It is directed that all measures are to be taken to control air pollution. Dust control measures be implemented at site along with sufficient anti-smog gun. Responsibility of any violation shall be of executing agency & EE should take action as per guidelines for any violation.
