During the inspection, following directions were given -

1. Progress of work was reviewed, which was not found satisfactory. Labour force was not found sufficient. Agency representative informed that work will be completed by Aug, 2024. It was directed to expedite the progress of work by deploying additional resources to complete the project without any further delay otherwise it would be difficult to complete it by Aug, 2024. Agency is directed to submit the revised program chart by 30.05.2024. It was suggested to show different activities into total and balance

## quantity with start and end date, so as to make Bar chart clear and more meaningful.

- 2. EE/F-12 informed that drawings for workshop and admin block were received on 24-04-2024 and were issued on 25-04-2024. Decision regarding pavement work has also been conveyed to the agency but drawings are yet to be received. In this regard, contractor has shown working drawing for pavement. In response, it was directed to submit pavement drawing after vetting so that it may be issued by department.
- Contractor gave proposal for application of GRC tiles on boundary wall to make it
  aesthetically pleasing. In response, it was directed to EE/F-12 to co-ordinate with
  client department regarding the same and if approved by client, proposal for
  approval of competent authority may also be submitted accordingly.

4. EE/F-13 informed that agency has not yet submitted all the documents of electrical contractor as per agreement provisions. In response, it was directed to submit all the necessary documents as desired by EE/F-13 so that approval of competent authority for associated contractor may also be taken timely.

- 5. EE/F-12 informed that Chief Engineer (Flyover) during his inspection on 02-12-2023 directed not to construct boundary wall adjacent to DMRC boundary wall. During execution it is felt that that construction of boundary wall on that side is required. It was directed to submit proposal expressing its necessity for approval of CE (F).
- 6. Agency to adhere to all safety guidelines as per agreement, CPWD Works Manual Safety codes, Good structural engineering practices & as issued by GNCTD vide No. 4(60)/23-24/PWD-II/Roads (CD No 057742583)11054-47 dated 11.0, a Responsibility of any violation shalt be of executing agency & EE should take action as per guidelines for any violation
- 7. It is directed that all measures are to be taken to control air pollution. Dust control measures be implemented at site along with sufficient anti-smog gun. Responsibility of any violation shall be of executing agency & EE should take action as per guidelines for any violation. Dust-control measure should be made effective by proper use of anti-smog gun, sprinkler, covering of building material, removing of malba etc.
- 8. Barricading at site should be sufficient and clean. Sufficient marshals wearing safety jacket with PWD logo should be available.
