A review meeting was held under the Chairmanship of Superintending Engineer, F-1 on 21.08.2024 at 12 Noon in his conference room Mukarba Chowk, G.T. Karnal Road, Delhi – 110033 and also site was inspected.

During the meeting following points were discussed: -

1. As per the Agency's submissions physical progress at site has been adversely affected due to non-availability of funds. It was informed that efforts are being made & if funds does not come, work may be foreclosed

2. Considering the current scenario of non-availability of funds from the Transport Department agency is directed not to procure further any new materials and

continue the work with the materials already procured/brought at site.

3. Earth filling work at site has almost been completed but the structural drawing of CC pavement is yet to be submitted. Agency is directed to submit the drawing of the CC pavement at the earliest.

4. Agency is directed to submit remaining drawings for timely issuance of the GFC

drawings.

5. SE/F-1 has directed that the work be completed within the amount deposited by the client department to avoid any liabilities and no work is to be allowed to be executed beyond the A/A & E/S and payment for the work should be made after approval of Extension of Time (EOT).

During the inspection following points were discussed: -

1. Foundation work upto plinth level of all the buildings is completed and columns from ground floor to first floor of all the building is in progress.

2. As the site is in a low lying area and does not have proper drainage outfall therefore, site and its adjacent area are getting flooded frequently in current monsoon season causing delay in the project completion.

3. Agency is directed to adhere all safety guidelines as per agreement, CPWD Works

Manual Safety codes.

- 4. Agency is directed to carry out the work activity with utmost safety in the monsoon season to avoid heavy settlement of the road and if any settlement is observed that shall be repaired immediately to ensure the safe movement of traffic.
- 5. Agency is directed to submit the revised program chart.
