During the inspection, following observations were made -

The road on both sides is in a poor condition and wearing course is non-existent. 1. There are big potholes on the entire stretch which is a matter of great concern. Several written reminders have been given to the EE by undersigned but to no avail. The situation is totally unacceptable and agency is directed to rectify it without delay. If any mishap happens it will be responsibility of agency and filed staff is directed to take action as per agreement provisions. Agency representative assured that they will rectify the situation soon.

- 2. 18 Nos. of steel girder erected on which shuttering work is in progress. 100% PSC girders have been erected and 22 Nos of deck slab has been casted. Agency was asked to increase the pace of work in order to complete the work in time.
- Lighting arrangements should be improved for smooth movement of traffic during night.
- 4. At site, footpath at many locations is broken for diversion of traffic. Proper restoration and levelling at some location needs to done for smooth traffic flow.
- Agency informed that 11 Kva shifted. 66 Kva work is in progress in which BSES has
 dismantled all poles coming in the alignment, only the work of cross bonding is
 pending in front of Mandoli, Jail Gate No. 2, which being done by BSES.
- Agency was asked to submit the drawings of rain water harvesting (RWH) for approval and other remaining drawings.
- 7. It was also informed by the agency that tree cutting permission is still pending, which is affecting badly in the execution of RE wall on both side and cannot be completed without removal of tree coming in the alignment. Tree cutting permission is to be pursued vigorously.
- 8. It was also directed not to allow road cutting permission to BSES without deposit of road restoration charges to PWD for the works which beyond the approval of the ETC approval.
- 9. It was also directed to repair the road properly as road is found in very poos condition. Agency to adhere to all safety guidelines as per agreement, CPWD Works Manual Safety codes, Good structural engineering practices & as issued by GNCTD vide No. 4(60)123-24IPwD-IIIRoads (CD No 057742583)11054-47 dated 11.07.2023. Responsibility of any violation shalt be of executing agency & EE shouldd take action as per guidelines for any violation.
- 10. It is directed that all measures are to be taken to control air pollution. Dust control measures be implemented at site along with sufficient anti-smog gun. Responsibility of any violation shall be of executing agency & EE should take action as per guidelines for any violation.
- 11. Barricading at site should be sufficient and clean.
- 12. Sufficient marshals should be available at junction for safe movement of machinery and commuters. Marshalls should have safety jacket with PWD logo.
- Quality control as per provision of the agreement should be implemented at site without any laxity.
