During the inspection following point has been highlighted & observed :

- The agency has requested to expedite the decision on the Pavement Quality Concrete 1. (PQC) on the road at water-affected area. It is instructed that EE, F-31 to take action as per directions of CE, Flyover.
- The 500 dia Sewer line and manholes of DJB are infringing under the alignment of RE 2. Wall towards Nand Nagri Depot side. It was directed to agency to take up and expedite the matter with EE, F-31 and accordingly proceed this matter with the competent authority.
- EE is directed to update the status of 36 trees on E-Parivesh portal along with 27 no's of 3. trees on DPTA in all higher level meetings.

- 4. It was directed to the agency to complete all the major works upto July'2025 of the flyover, so that the same can be open in the interest public to get benefitted from the congestion and completion may be recorded at the earliest.
- Once the flyover is operational other remaining minor works shall be carried out in the supplementary agreement on the lines of Punjabi bagh and Anand Vihar flyovers.
- 6. The agency is directed to submit the art work proposal at the earliest.
- 7. Debris, silt, and malba deposited at the service road, drain, and near the ramp must be removed immediately.
- 8. Several drain covers are missing on both sides of the road, posing an accident risk. The agency is directed to urgently provide all missing drain covers. Site staff are to take immediate action.
- The agency is directed to enforce all safety measures, including improving lighting arrangements for smooth traffic movement during night time.
- Sufficient marshals must be deployed at junctions to ensure safe movement of machinery and commuters. Marshals should wear safety jackets with the PWD logo.
- 11. The agency is directed to implement dust control measures, including the use of adequate anti-smog guns. Quality control, as per the agreement's provisions, must be strictly enforced without any laxity. It is directed that all measures are to be taken to control air pollution. Dust control measures be implemented at site along with sufficient anti-smog gun.
- Agency to adhere to all safety guidelines as per agreement, CPWD Works Manual, Safety codes, Good structural engineering practices & as issued by Delhi govt from time to time.
