SUBJECT: Request for Nomination of an officer on the Committee—Regarding

Sir/Madam,

Please refer to this office letter of even no.F.3(114)/Policy/DDCD/2020/1320-29 dated 17.12.2020 vide which it was conveyed that the Dialogue and Development Commission of Delhi (DDCD) is a premier think-tank of the Government of NCT of Delhi and is involved in the various activities including advising the government in finding sustainable, people-centric solutions to the critical development challenges facing Delhi.

The Government of NCT of Delhi has a number of departments undertaking varied activities. A large number of projects and activities in these departments involve certain functional and evaluation expertise, encompassing preparation of terms of reference, preparation of bid documents, follow-up on project deliverables, key performance indicators and overall project monitoring. For these tasks -which play a role in ensuring effective and efficient project implementation departments require support from external domain experts (particularly, given the lack of the said expertise within the departments).

DDCD has been entrusted by the Hon'ble Dy. C.M to undertake the process for the empanelment of firms for various consulting and IT implementation project across departments of Government of NCT of Delhi, so as to make the mechanism of empanelment more efficient - in terms of time, cost and working.

For the aforesaid purpose it has been desired to constitute a committee under the Chairmanship of Sh Gopal Mohan, Member, DDCD, with a member each from Finance Department, IT Department, AR Department, Planning Department and one executive engineer (with knowledge on procurement processes) from either DJB, PWD or DUSIB. The committee shall be responsible for scoping study of similar models adopted elsewhere including NCSI model to gauge the best practices and bottleneck (that will need to be overcome). This committee shall also be responsible for drafting the tender documents to invite application from reputed firms/entities for empanelment to advise on various consulting (Tier A) and IT implementation (Tier B) projects.

Vide letter dated 17.12.2020 of this office it was requested to kindly nominate a suitable officer from your department, for nomination on the proposed committee, and convey the same to this office urgently (preferably within a week).

The requisite information is still awaited.

So, it is once again requested to kindly nominate a suitable officer from your department, for nomination on the proposed committee, and convey the same to this office urgently so that further action could be taken on the subject matter.
