Subject:- Compliance of the directions of the Hon'ble Delhi High Court passed from time to time in the matter of WP(C) No. 104/2015 titled as Guru Hanuman Society of India Vs GNCT of Delhi & Ors. - Proposal for regularization of Speed calming Measures (71 Nos.) in the area of East, Delhi.

Sir,

Hon'ble High Court of Delhi in the above cited matter has directed to provide cross linkages of the approved/authorized speed breakers with the approval/sanction. This matter was also discussed in a meeting held by Jt.CP/Traffic-HQ on 04.09.2018 to discuss the status of Traffic Engineering proposals in which PWD representatives suggested that in case of non availability of record of approval of the 422 authorized speed breakers out of 589 locations of speed breakers which were reported to be authorized by the area traffic police officers after conducting joint inspection with the field officials of PWD and other concerned agencies, Delhi Traffic Police may issue fresh orders/approvals for regularization of these speed breakers as per present feasibility. Accordingly, as per the discussions held in the above cited meeting, fresh field surveys are being conducted by the area traffic police officer to examine the feasibility of these 422 speed breakers/locations. Out of these 422 authorized speed breakers fresh feasibility reports/recommendations have been received from the area traffic police officers in 71 cases which is mentioned below-


